STIPULATION OF DISMISSAL

WHEREAS Cambr Company ("Cambr") filed suit in this action asserting antitrust claims that had accrued to the Solgar Vitamin & Herb Company and/or related entities ("Solgar Antitrust Claims"); and

WHEREAS the United States District Court for the Southern District of New York ruled in American Home Products Corp. v. Cambr Co., 00 Civ. 2021 (V.M.) (S.D.N.Y.), that the Solgar Antitrust Claims belong to American Home Products Corporation ("AHP") and that Court entered a declaratory judgment and an injunction prohibiting Cambr from pursuing the Solgar Antitrust Claims; and

WHEREAS Cambr wishes to comply with the Order of the Southern District of New York and cease its pursuit of the Solgar Antitrust Claims and allow AHP alone to continue to pursue the Solgar Antitrust Claims as part of American Home Products Corp. v. F. Hoffman-La Roche Ltd., et al., Case No. 00-Civ-3117 (S.D.N.Y.);

IT IS HEREBY STIPULATED AND AGREED among Plaintiff Cambr Co. and the Stipulating Defendants that:

1. This action is voluntarily dismissed with prejudice pursuant to Rule 41(a)(1) of the Federal Rules of Civil Procedure;

2. This dismissal is without prejudice to and will have no bearing upon AHP's right to continue to assert and pursue the Solgar Antitrust Claims in American Home Products Corp. v. F. Hoffmann-La Roche, Ltd., et al., Case No. 00-Civ-3117 (S.D.N.Y.), which has been consolidated as part of In Re Vitamins Antitrust Litigation, MDL No. 1285, Misc. No. 99-0197 (TFH) (D.D.C.).

3. This dismissal is without prejudice to the claims asserted by other plaintiffs in the above captioned action.


