STIPULATION CONCERNING THE TIME OF AKZO NOBEL
N.V. TO RESPOND TO THE COMPLAINTS IN THE
CAPTIONED ACTIONS

IT IS HEREBY STIPULATED AND AGREED, by and between
counsel for plaintiffs in the captioned actions and counsel for
defendant Akzo Nobel N.V., that the time for defendant Akzo No-
bel N.V. to move, answer or otherwise respond to the complaints
in the captioned actions, shall be extended to and including
April 28, 2000, provided that if a motion to dismiss is served,

Akzo Nobel N.V. will not assert that service was not proper under the Hague Convention. The execution of this Stipulation on behalf of Akzo Nobel N.V. shall be without prejudice to any other defenses it may have, including, without limitation, lack of personal jurisdiction and improper venue.
