MOTION TO UNSEAL WITH REDACTIONS

The United States of America, by and through the undersigned counsel, respectfully seeks to unseal the materials in this matter, with appropriate redactions. Pursuant to this Court's prior Order, the United States provided its proposed redactions of the (1) the Application for a Search Warrant; (2) the Affidavit in Support of that Application, with attachments and Annex;¹ and (3) the signed Search Warrant and attachments (collectively, "the Search Warrant Materials"), attached as Attachment A, to counsel for Mr. James Wolfe and [REDACTED]. Neither counsel requested any additional redactions to the materials.

As discussed in the previous filing, undersigned counsel has determined that there is no present law enforcement reason for continued sealing of the unreacted material in the Attachment A, but that the reacted portions should be redacted to protect legitimate privacy and law enforcement interests that are consistent with Leopold v. United States, 964 F.3d 1121 (D.C. Cir. 2020). Because this motion (and the Motion to Partially Unseal for a Particular Purpose) identify a witness by name, and the title of this matter contains personal identifying information (IMEI number), the government seeks leave to file this motion under seal. The government herein

proposes redactions to the prior Motion and Order, and this Motion and proposed Order (Attachment B shows the proposed redactions in boxes, and Attachment C shows the redactions in full). The government also requests that the title of this matter be redacted to remove the IMEI number, as described in the proposed Order.
