Pending before the Court is the government filter team's request, filed in response to the Court's December 16, 2022 Minute Order ("December 2022 Minute Order"), for the partial unsealing of the Order issued on September 27, 2022, ECF No. 16 ("September 2022 Order"), related to the same-dated Memorandum Opinion partially unsealed on December 15, 2022. *See* Gov't Filter Team's Supplemental Status Report (dated December 16, 2022), ECF No. 33. This request is granted.

On December 15, 2022, the Court granted the government filter team's December 14, 2022-dated request for the partial unsealing of two decisions: a Memorandum & Order, issued on June 27, 2022 ("June 2022 Memorandum & Order"), ECF No. 4, and a Memorandum Opinion, issued on September 27, 2022 ("September 2022 Memorandum Opinion"), ECF No. 17. *See* Order, ECF No. 32. The Court then ordered the government filter team to file a supplemental memorandum explaining why the September 2022 Order related to the September 2022 Memorandum Opinion could not also be unsealed, to which the government filter team responded by requesting the partial unsealing of the September 2022 Order.

Upon consideration of the government filter team's request, as well as the government

filter team's submission, on December 16, 2022, of a proposed redacted version of the

September 2022 Order, it is hereby:

ORDERED that the government filter team's proposed redactions to the September

2022 Order are accepted, as reflected in the Redacted September 2022 Order attached to this

Order; and it is further

ORDERED that this Order, along with the Redacted September 2022 Order attached

to this Order as Attachment A, be unsealed and posted by the Clerk of the Court for public

access on the appropriate part of the Court's website; and it is further

ORDERED that the government filter team shall file, by the earlier of December 16,

2023, or within thirty days of when any public disclosure obviates the need for further

sealing, a status report advising the Court whether the September 2022 Order may be further

unsealed, in whole or in part, and, if so, proposing any redactions to be made prior to any

unsealing.
