PUBLIC NOTICE: Jury Duty Email, Text, and Phone Scam Alert

To the Citizens of Washington, DC,

The United States District Court for the District of Columbia has been made aware of a recent scam regarding induvial impersonating court officials. This scam targets citizens via unsolicited and fraudulent emails, text and phone calls.

The fraudulent email instructs the recipient to complete the jury duty form by clicking on a link. These emails may also threaten legal action, fines, or arrest unless immediate payment is made, or personal information is provided.

The phone calls falsely claim the recipient missed jury service and has a warrant for their arrest. It also states that the recipient must withdraw money and report to an unknown location to pay a fine. Additionally, the fraudulent text messages ask citizens to click on a link for a one-time pass code to receive a payment for jury duty.

Please be advised:

- The United States District Court will not send you a summons via text, nor ask you to complete a questionnaire via text. All summonses are sent via postal mail.
- The court will never ask for payment, credit card information, or Social Security numbers via phone, email, or text.
- Do not click any links or download attachments from suspicious emails claiming to be from the court.
- If you receive such a message do not respond or provide any personal information.
- Do not send money or gift cards under any circumstances.
- Report the incident to your local law enforcement agency and the Federal Trade Commission at https://reportfraud.ftc.gov.
- You may also contact the court directly at 202-354-3360 to verify the legitimacy of any jury summons.
